

**Decisions of Regional Transport Authority, Kozhikode
Meeting held on 04.10.2017 at Collectorate Conference Hall,
Kozhikode.**

Item No. 1

Heard. Granted concurrence for renewal of regular stage carriage permit in respect of S/C KL 09 X 959 without prejudice to the right of the primary authority to fix the class of service according to the length of route and subject to verification of scheme violation if any by the original authority

Item No. 2

Heard. This is for concurrence for fresh regular stage carriage permit to operate on the route Vilayil-Kozhikode-Areekode-Edavannapara-Vazhakkad-Mundumuhi-Oorkadavu-Peruvayal-Medical college and Poomkudi as OS. The portion lies in this district is 18 Kms from Kavanakallu Bridge to Palayam where an overlapping on notified sector from CPO to Palayam a distance of 0.7 km. Concurrence **Granted** without prejudice to the right of the primary authority to fix the class of service according to the length of route and subject to verification of scheme violation if any by the original authority

Item No. 3

Heard. Granted concurrence for renewal of regular stage carriage permit in respect of S/C KL 13 J 8199 as LSOS without prejudice to the right of the primary authority to fix the class of service according to the length of route and subject to verification of scheme violation if any by the original authority

Item No. 4

Heard. Granted concurrence for renewal of regular stage carriage permit in respect of S/C KL 13 AC 7988 as LSOS without prejudice to the right of the primary authority to fix the class of service according to the length of route and subject to verification of scheme violation if any by the original authority

Item No. 5

Heard. Granted concurrence for renewal of regular stage carriage permit in respect of S/C KL 59 C 9900 as LSOS without prejudice to the right of the primary authority to fix the class of service according to the length of route and subject to verification of scheme violation if any by the original authority

Item No. 6

Heard. Granted concurrence for renewal of regular stage carriage permit in respect of S/C KL 12 J 9199 as LSOS without prejudice to the right of the primary authority to fix the class of service according to the length of route and subject to verification of scheme violation if any by the original authority.

Item No. 7

This is to re consider the application for fresh regular stage carriage permit which was adjourned for seeking concurrence in RTA dtd.4-3-2017 for operating on the route Edavanna – Areacode – Cheruvady – Mavoor -Kozhikode. Concurrence granted by RTA Malappuram produced.The major objection was about time clash.Hence application **granted** subject to settlement of timing.

Item No. 8

This is an application for fresh regular permit to operate on the route Pantheeramkavu (starting single trip from Pantheeramkavu via. Perumanna, Poovattuparamba, Velliparamba, MCH, Kovur, MLA Road) (via) Velliparamba, Ummalathur Road, Ummalathur Thazham, Hilite Junction, Pantheeramkavu, Azhinhilam, Parammal and Bank Road OS.Objection of KSRTC and others that this application has a route with objectionale overlapping.Enquiry officer reported that there is only 0.4km which is within the permissible limit. Hence Fresh stage carriage permit **granted** subject to settlement of timing.

Item No. 9

This is an application for fresh regular permit to operate on the route Thiruvambady – Mukkam – Kodenchery – Adivaram - Nellipoyil via Agastiamuzhi – Thondimmal – Murampathi – Kannothe - Knwoledge city – Kaithappoyil - Kattiad valavu – Irumpakam – Pallipadi - Pullurampara and halt at Thiruvambady as OS. Fresh permit **granted** subject to settlement of timing.

Item No.10

This is an application for fresh regular permit to operate on the route Eranhikkoth – Omassery – Kunnamangalam - via Pilassery - Eranhikkoth Jn - Kurungattakadavu bridge – Pullannur – Mundottupoyil – Narakassery – Rayarukandy – Nadammalpooyil – Nagalikavu - Puthur Jn - Saj Jn as OS. Freah permit **granted** subject to settlement of timing.

Item No. 11

This is an application for fresh regular permit to operate on the route Narikkuni – Balussery - Kinalur Estate - via Punnassery – Karakunnu –Nanminda - Vattoli Bazar as OS. Fresh permit **granted** subject to settlement of timing.

Item No. 12

This is an application for fresh regular permit to operate on the route Vellannur – Kunnamangalam - Mavoor via Saj Jn - Toddy shop –Koozhakkode – Kanniparamba – Kurikkathur – Milma - Ishtika Bazar –Muzhappalam - Peringalam as OS. Fresh permit **granted** subject to settlement of timing.

Item No.13

This is an application for fresh regular permit to operate on the route Mavoor – Kattangal – Omassery - via Vellalassery – Choolur – Malayamma - Puthur as OS. Fresh permit **granted** subject to settlement of timing.

Item No.14

This is an application for fresh regular permit to operate on the route Mavoor - Mukkam via Cheruvadi – Pulparamba – Kattangal - Manassery as OS.

Fresh permit **granted** subject to settlement of timing.

Item No.15

This is an application for fresh regular permit to operate on the route Kanniparamba – Mavoor - Medical college - Moffussil stand – CPO -Palayam stand as OS.

Fresh permit **granted** subject to settlement of timing.

Item No.16

This is an application for fresh regular stage carriage permit to operate on the route Thottumukkam – Mukkam – Thiruvambady - Kozhikode via Mysorepatta – Thekkukutty – Mukkam – NIT – Kunnamangalam –Karanthur - Medical college – Omassey – Thondimmal - Vallathaipara as OS. **Adjourned** with direction to Sec.RTA to enquire and report whether there is any objectionable overlapping as objected by KSRTC and place before ensuing RTA .

Heard, both the applicants. Transfer of permit is **allowed** from Smt.Sujeera to Sri.Abdulla as applied for subject to clearance of Govt dues.

Item No.18

Heard, both the applicants. Transfer of permit is **allowed** from Sri.Muhammed Anas to Sri.Jasir as applied for subject to clearance of Govt dues.

Item No.19

Heard, both the applicants. Transfer of permit is **allowed** from Sri.Gireeshkumar to Sri.Basheer.A as applied for subject to clearance of Govt dues.

Item No.20

Heard, both the applicants. Transfer of permit is **allowed** from Sri.Abdul Rasheed to Sri. Ajeesh as applied for subject to clearance of Govt dues.

Heard, both the applicants. Transfer of permit is **allowed** from Sri.Jayanandan to Smt.Nisha as applied for subject to clearance of Govt dues.

Item No.35

Heard for grant of renewal of permit in respect KL 42 9970 operating on the route Kondotty-Areekode-Mukkam-Thamarassery.Renewal of permit **granted**.

Item No.36

Heard for grant of renewal of permit in respect KL 56 P 8055 operating on the route Cheekilode-Kozhikode-Medical college.

- 1-Delay condoned
- 2-Renewal of permit **granted**

Item No.37

This is an application to re consider the decision dtd.27-11-2016 RTA.Perused the judgment in MVAA No.188/2016 of Hon'ble STAT.This is a prolonged item with several litigations and were disposed of and a decision taken by RTA in its meeting held on 16-2-2016 and the decision was as follows,

- A. The order of revocation of sanction for transfer of permit issued vide item No. 87 at the meeting of the Regional Transport Authority on 6.10.2009 is withdrawn.
- B. For regularizing the issues of transfer of permit, replacement of KRD 8253 and renewal of permit for current period, the adjourned

item 56 at the meeting of the Regional Transport Authority on 26.3.2010 regarding renewal of permit from 22.8.2006 is reconsidered and granted notionally for the period from 22.8.2006 to 21.8.2011.

- C & D. Adjourned item 56 at the meeting of the Regional Transport Authority on 26.3.2010 regarding replacement of stage carriage KRD 8253 is reconsidered and replacement allowed with KL-11/Q 5601 as applied for on 5.2.2016.
- E. The delay in presenting the application for further renewal is condoned under Section 81(3) of the act subject to remittance of compounding fee of Rs. 5000/- for default of operation and renewal of permit for five years from 22.8.2011 is granted to KL-11/Q-5601 as applied for on 5.2.2016.

This again challenged before Hon'ble High court in WPC No.10450/2016 and the judgment was that the issue is covered by the decision reported in Usman VS Regional Transport Authority (2015(4) KLT 25 and quashed the decision of Regional Transport Authority. And also directed to reconsider the application for renewal of permit and the question of replacement comes there after. At the same time objectors produced an order of Hon'ble High court in OP (c) No.2316/2017 extending the interim stay until further orders in the judgment in MVAA No.188/2016. Hence the application for renewal and replacement of permit with respect to the vehicle KRD 8253 on the route Beypore –Bhatt Road-City has been **rejected** on the basis of Usman Vs Regional Transport Authority (2015(4) KLT 25.

Item No.38

Heard all concerned and perused the Judgment in MVAA No.12/2016. This is an application for fresh stage carriage permit on the route Payyadimeethal-City in the vacancy of KLZ 9915 and which was expired on 16-1-2001. This application is in city limit and number of stage carriages in Calicut city has been restricted to a maximum number as 400 including the reservation to scheduled castes and scheduled tribe. When considering this as a fresh permit on the route Payyadimeethal to city with a route length 15.2km includes overlaps on the nationalised sector from city to Francis Road 1.6 km on Payyannur-Ernakulam. This violates GO(P) No.42/2009 Hence application for fresh permit on the route City-Payyadimeethal has been **rejected**.

Item No.39

This is an application for fresh regular stage carriage permit on the route Chulliyode-Kozhikode in the vacancy of KL 12 A 378. This route included in notified route vide GOP No. 42/2009. The notification vide 8/2017 excluded operation of new permits and saved permits granted in private sector upto 14-7-2009 only and issue of new permits is violation of Notification No.8/2017.

KSRTC vehemently objected the issue of fresh regular stage carriage permit. Hence this application is **rejected**

Item No.40

Heard for grant of renewal of permit in respect KL 58 C 9495 operating on the route Aroor-Kozhikode-Areekode. Renewal of permit **granted**

Item No.41

This application is to consider the replacement of the permit of the vehicle KL 09 K 2350 to KL 11 Z 459. Objection of Sri.Sulaiman is that he has some financial dealings in connection with out going vehicle KL 09 K 2350 and a case is pending in Kunnamangalam JCFM court. There is also a judgment from Hon'ble High court in WPC No.25170/2016 to consider this application. Hence it is clear that there is no legal impediment to consider this application and **granted replacement** subject to realisation of Government revenue and check report if any.

Item No.42

This is an application for variation of permit in respect of KL 11 S 808 operates on the route Malikadave-Medical college variation requested is 1) Extension from Malikadavu to Puttattutjazham 2) extension from City to Railway station. 3) extension from Arayidathpalam to Kalipoika. 4) Curtailment of 4 trips from City to Medical college. Heard all parties concerned and KSRTC. Perused the Judgment in MVAA No.14/2016 dtd.22-6-2016 and found this application is for a variation with three trips to Puttattuthazham which is an ill served area and variation through Railway station – Medical college and Kalipoika. More stage carriage service through Railway station connecting KSRTC and Moffussil Bus stand is beneficial to travelling public and KSRTC not objected this application. Hence **granted** subject to settlement of timing.

Item No.43

This is an application for variation of permit in respect of KL 02 S 171 operates on the route Malikadave-Payyanakkal variation requested is Extension from Malikadavu to Morikkara. This application for variation curtailing two trips to Payyanakkal and number of objections from residents of Payyanakkal North and Mavilikadavu received and represented in the RTA about their difficulties if the existing facility reduced. Hence it is found this proposal is against the interest of travelling public and no changes in any circumstances to consider this application. Hence **rejected**.

Item No.44

This is an application for variation of permit in respect of KL 11 S 318 operates on the route Perumthuruthikadavu-City –RailwaStation-Medical College – Cherukulam.

This application is for variation reducing five trips from Railway station will adversely affect the travelling facility of huge passengers from Cherukulam via Kakkodi to Railway station. And starting and halting also proposed to vary and travelling public objected as it is highly depriving the existing facility of commuters. Hence the proposal is against the interest of travelling public and there is no changes in any circumstances to consider the application. Hence **rejected**.

Item No.45

This is an application for variation of permit in respect of KL 56 A 905 on the route Vattoli - Thamarassery - (Via) Koduvally Choyimadam. This application is to curtail three trips from Katharammal to Poonur via Choyimadam and extension from Katharammal to Elettil Vattoli and one trip Katharammal to Avilora. In this proposal there is variation in trip from Katharammal to Koduvally which include notified sector. This is a clear violation of Notification No.8/2017. Hence **rejected**.

Item No.46

This is an application for variation of permit in respect of KL 11 R 2071 conducting service on the route MundikkalThazham-Kozhikode-Thottumukkam via Mukkam-Karamoola-Koodaranhi-Koombara--Maranchatty-Agasyamuzhi-Manassery-Kattangal-KGM-Karanthur-M/college – Neeleswaram – Omassery - Thiruvambady. Heard and found there is serious objections from KSRTC that there is one additional trip proposed in this application from Kunnamangalam to Karanthur which violates the scheme GOP No.42/2009 clause 19. Hence **adjourned** with direction to conduct detailed enquiry and place in the ensuing RTA.

Item No.47

This is an application for variation of permit in respect of KL 11 R 4102 conducting service on the route Beypore-Malikadavu via-Karaparamba-Krishnan Nair Road. Variation requested is to vary with extension to Puttattuthazham and that extension is beneficial to travelling public where as trip during night to Beypore at 9.05 Pm will be grave hardship to travelling public from City. City transport is highly essential in night after 9'o clock and 10'o clock. for the economic activities to sustain. There is no changes in the circumstances on the route to consider this application. Hence **rejected**.

Item No.48

This is an application for variation of permit in respect of KL 36 3230 on the route Thottumukkam-Areakode – Cheruvady – Mavoor - medical College - Kozhikode. In the variation request comes a portion in Malappuram RTA. Hence **adjourned** with direction to Sec.RTA to seek concurrence fro RTA malappuram.

Item No.49

This is an application for variation of permit in respect KL 18 B 3132 conducting service on the route Oloppara-Peruvazhikkadavu-via Kakkodi-via Kakkodi-Palayam-extn two trips to Badirur via Kottoopadam by curtailment of one Peruvazhikkadavu.Variation requested is -Extending 6 trips from Oloppara to Aripurathuthazham-.Curtailment of one Badirur trip at Chelapram to Aripurathu thazham.Curtailment of Peruvazhikkadavu trip.

There are strong objections from various public organisations and residents association such as Peruvazhikkadavu residents association and Samanuaya residents association and found that the proposal is depriving limited stage carriage services from Peruvazhikkadavu to Medical college which is an ill served area and there is no changes in any circumstances to consider this application. Hence **rejected**.

Item No.50

The learned counsel for the applicant stated that the application for variation is not pressing. Hence the application is **not considered**.

Item No.51

This is an application for variation of permit in respect Kl 57 3379 conducting service on the route Badiroor -Kulangarapedika-Medical College.Variation requested is Curtailment of Kulangara Peedika portion,Curtailment of one Medical College trip and one additional trip to Badirur.Perused the Judgment in MVAA No.18/2016.There are objections from various groups of public including Priya Darsini Swayam Sahaya Sangam about the deprivation of travelling facility to the ill served area Unimukku-Badirur. Hence it is found this proposal is against the interest of the travelling public and there is no changes in any circumstances to consider this application. **Hence rejected**.

Item No.52

This is an application for variation of permit in respect of KL 10 Q 4401 conducting service on the route Mundakkal-Kozhikode-Areekode via Kunnamangalam-NIT-Mukkam.On verification it is found that the variation sought for is a deviation from Mundakkal to Mukkam instead of Mundakkal-Kuttikadavu-Mavoor REC via Mukkam. This is through Kunnamangalam,REC with an overlapping on Nationalised sector. Hence **adjourned** with direction to enquire and report this specifically and place before next RTA.

Item No.53

This is an application for variation of permit in respect of KL 11 AA 3850 conducting service on the route Chevarambalam - Kozhikode Rly station -via Kottoli - Netaji Nagar - New busstand - Mananchira. Variation requested is Extension from Chevarambalam to Eringadanpalli. **Granted** subject to settlement of timing and fitness from PWD.

Item No.54

This is an application for variation of permit in respect of KL 12 B 6934 2016 conducting service on the route Ramanattukara – Pantheerankavu -Oorkkadavu – cheruppa – mavoor - medical college via Parammel junction. Variation requested is additional trips from Perumanna to Mavoor and Pantheerankavu to Ramanattukara. There is serious objection from KSRTC about objectionable overlapping. Hence **adjourned** with direction to Secretary RTA for detailed enquiry and place before next RTA.

Item No.55

This is an application for variation of permit in respect of KL 11 S 5949 conducting service on the route Kozhikode Palayam Bus stand-Areekode via-Medical college-Koolimadu-Chullikkapaambu-Eranhimavu.Variation requested is additional trips from Mavoor to Areecode to and fro. Variation sought comes a portion in RTA Malappuram.Hence **adjourned** with direction to seek concurrence from RTA Malappuram and place before next RTA.

Item No.56

This is to re consider the rejected item of RTA dtd.27-11-2015 for variation of permit in respect of KL 11 AD 5763 in the light of Judgment in MVAA No.13/2016.Perused the Judgment.Variation requested is (1)-Extension from City to Payyadimeethal 2) Two round trips curtailment from West Hill to City 3) One round trip curtailment from Meenchanda to Karad

The additional trip requested is from City to Payyadi meethal which is passing through Nationalised route Bank road to Mananchira for a distance of 0.3 km. The argument of the applicant is due to curtailment of other trips the total length of overlap remains same after variation. But the notification in GOP No.42/2009 clause 19 prohibited introducing new route or trip on this sector and this proposal is a violation of scheme and hence **rejected**.

Item No.57

This is an application for variation of permit in respect of KL 18 A 8425 on the route CHERUKULAM - BEACH HOSPITAL, Circular Trip Touching Beach Hospital via Ambalapady, Eranhikkal, Pavangad, CH Over bridge,Karaparamba and Kakkodi as City Service.Variation requested is One round trip between ottathengu and kakkodi panchayath. Four trip deviation from Railway to beach hospital through new bus stand and mavoor road. One trip deviation to beach hospital through city.This includes curtailment of trip to Railway station which is on prime time and will deprive the facility of travelling public and deviation sought to Beach Hospital also violates GOP No.42/2009 clause 19 since it overlaps in notified sector. Hence **rejected**.

Item No.58

This is an application for variation of permit in respect of KL 11 AJ 7738 conducting service on the route Vakayad-Kozhikode via Balussery Kakkur

Kakkodi.Variation sought is one additional trip from Balussery to Kozhikode which is a well served route and there is overlapping on Nationalised sector.The curtailment sought for is from Balussery to Vakayad an ill served area and there are serious public objection against depriving their limited facility available. There is no changes in any circumstances to consider this application and hence **rejected.**

Item No.59

This is an application for variation of permit in respect of KL 57 N 9911conducting service on the route Thiruvambady-Kodenchery-Mukkam-Kaithapoyilpadam. This application is a variation with extension from Kaithapoyil to Adivaram which is on Nationalised sector and violation of scheme GOP No.42/2009 clause 19 and extension from Pulloorampara to Koodarani. The variation with extension on Nationalised sector cannot be considered and hence **rejected.**

Item No.60

This is an application for variation of permit in respect of KL 11 P 9656 conducting service on the route Vakayad-Kozhikode via Balussery Kakkur Kakkodi. Variation requested is one trip reducing Thamarassery chungam to kakkad,One additional trip from Thamarassery chungam to muttanchery and one additional trip from Elettil Vattoli to Narikkuni. This is an application for variation from Thamarassery to Muttanchery via Chungam passing through Nationalised route from Thamarassery to Chungam in the proposed variation.This will be violation of Notification vide GO No.8/2017. **Hence rejected.**

Item No.61

This is an application for variation of permit in respect of KL 73 9279 conducting service on the route Nambiarkunnu - Kozhikode (via) -Puthankunnu - Pazhoor - Cheeral - S.Bathery - Meenangadi - Muttill - Vi.hospital - Edappetty - Kainatty - Kalpetta LSFP. Variation requested is

1. Curtailment portion Vellaramkunnu to Kalpetta via Govt.College, Puzhamudi, Fathima Hospital
2. Variation from Vellaramkunnu to Kalpetta via Dist.Collector, Benglaw old traffic police station Bypass Gudallaji Road-Jaithra theatre. 3.Not change of the existing running time.

Perused the Judgment in MVAA No.5/2016 dtd.30-3-2017 of Hon'ble STAT. Orginal permit operating on Nambiarkunnu -Kozhikode with deviation at Vellaramkunnu to Kalpetta via Government Collage, Puzhapudi via Fathima Hospital to avoid the objectionable overlapping on Nationalised sector. In this fresh application, operator sought to avoid deviation from Vellaramkunnu to Kalpetta via District Collectors Banglaw, Old Traffic Police Station, Bye-pass, Gudallaji Road, Jaithra Theater. In effect the operator is seeking variation of his permit to operate almost directly on Nationalised route. Notification vide GOP No.8/2017 prohibited variation on saved permits permitted to operate as it is only. This proposal vehemently objected by KSRTC on the basis of the

provisions of above Notification. Heard the petitioner and all objectors and found this variation is violation of Notification No.8/2017 and hence **rejected**

Item No.62

This is an application to implement the decision taken by STA in its meeting held on 14-6-2017 for fixing age limit for applying and granting for fresh regular stage carriage permits as follows in the light of the Judgment of Hon'ble High court.

- a) 8 years for ordinary stage carriage from the registration of the vehicle.
- b) 7 years for city /town services from the registration of the vehicle
- c) 5 years for LSOS from the registration of the vehicle

Heard all concerned and **decided to implement** the decision dtd.14-6-2017 of State Transport Authority.

Item No.63

This is an application to implement the decision taken by STA in its meeting held on 14-6-2017 for granting renewal of permit without insisting concurrence from sister RTA's eventhough it is inter district permit in the light of judgment of Hon'ble High court in WPC No.1786/2017.

Heard all concerned and **decided to implement** the decision dtd.14-6-2017 of State Transport Authority.

Item No.64

This is to implement the Judgment of Hon'ble High court in WPC No.11506/2017 and directs the Secretary RTA to enforce the legal provision against the violations by the Jeep and Tata Aceas ordered by Hon'ble High Court. And also directed the police Authority concerned having jurisdiction in this area to take stringent action as ordered by Hon'ble High Court.

Item No.65

This is an application for action against stage carriage KL 58 R 8388 operated touching more than two intermediate points without deviating through Lakkidi via Thalappuzha-Vythiri on nationalised route on 2-11-2016 and touching Old Bus stand Thamarassery an intermediate point without deviating through Kudukkilummaram on 30-01-2017 and found conducting service through an intermediate point in between Government college junction and Kalpetta Puthiya bus stand on 7-3-2017 and found conducting service through nationalised route on Thamarassery town without deviating court road on 11-4-2017. There are regular complaint of KSRTC about this violations causing serious financial loss to KSRTC. This is a clear violation of the permit conditions and punishable under section 86(a)(b). Hence the permit of KL 58 R 8388 vide permit No 11/413/2004 on the route Kozhikode-Sultan Battery valid from 1-4-2014 to 31-3-2019 has been **suspended for 30 days** from 5-11-2017 and registered owner is directed to report the place of garage during the period of suspension. The Secretary, RTA is directed to arrange verification of the service of the vehicle

during the suspension period and intimate the jurisdictions through which it operates
