There are objection against this variation and requests for this variation from various public representatives. Considering all petitions and hearing all presented and found over all this variation is beneficial to the travelling public. Hence granted subject to settlement of timings”.

This is a representations from **Sri,Sajeevan PTK** and 11others in the light of the WP(c) No.12710/17 DT 10/04/2017and Sri. Divyan.M in the light of WP© No. 14544/2017DT 25/04/2017 of Hon'ble High Court for **VM municipal auto permits**. This is an application by Sri.Sajeevan PTK and 11 other and Sri.Divyan to consider the application for halting place at Vatakara. This matter was considered by RTA held on 08.03.2017 and entrusted Secretary RTA to consider the request filed by the petitioners. The applicants produced various judgments of Hon'ble High Court in WP(c) No.12710/2017 directing RTA to consider the same on merits, in the light of the decision in (Rajesh V Secretary, RTA (supra) and in WP(c) No.14544/2017 directing RTA to consider in accordance with law and attain finality to same after providing a opportunity of hearing the petitioner and all other interested persons.

“Heard. The legal position is that there is no Government Notification to limit the number of autorickshaws in Vatakara Municipality and Sec. 74 of MV Act 1988 provides for issue of permits to contract carriages. The problem raised by existing autorickshaw Unions are the shortage of parking places and reduction of income due to issue of further permits to new autorickshaws and allowing variation of permits to halt at Vatakara municipality.

The order of Hon'ble High court is clear that this authority should pass order on these applications according to present law in force controlling the permit of Autoriockshaws. Hence this Secretary RTA is directed to issue VM permits to applicants of autorickshaws as prescribed in Sec 74 of MV Act 1988, in the absence of Govt. Notifications limiting the number of permits in Vatakara Municipality under Sec. 74(3) of MV Act 1988.

This is an application to consider the request for change to bus stop of old Kadiyangad brige to new Kadiyangad bridge. “Heard. Granted with the condition that the bus stop should be provided at wider portion of the road without any chance for accident due to stopping of buses on both sides in a distance enough to avoid road blocks and subject to the permission of PWD roads, local body and traffic Police”.
